

MINUTES OF REGULAR MEETING OF THE BOARD OF EDUCATION OF
SPARTA COMMUNITY SCHOOL DISTRICT #140
RANDOLPH COUNTY, ILLINOIS,
HELD AT SPARTA LINCOLN SCHOOL
IN SAID SCHOOL DISTRICT AT 7:00 P.M.
ON THE 14th DAY OF SEPTEMBER 2017

The budget hearing was called to order at 7:00 p.m. by Vice President Kevin Holliday.

Treasurer/Bookkeeper Tina Witherby presented the FY18 budget. With no questions or comments, the meeting continued.

Howard Gallois moved, Alan Young seconded to adjourn the budget hearing at 7:15 p.m. Roll call vote. Yeas: Gallois, Young, Byington, Craig, Kempfer and Holliday. Nays: none. Motion carried.

The regular meeting was called to order and upon the roll being called, Kevin Holliday and the following members of the Board of Education answered present: Bert Byington, Angela Craig, Howard Gallois, Kenneth Kempfer and Alan Young. Absent: Corey Rheinecker. Others present were: Superintendent Dr. Gabrielle Schwemmer, Recording Secretary Tina Witherby; Principals Jayson Baker, Scott Beckley and Amy Price; and members of the faculty, community and press (*County Journal*).

Board Vice President Holliday led everyone in the Pledge of Allegiance.

Rosette Clay asked that the Board not frivolously spend any cash reserve. She again asked if the district had the archives for the Vernon School. She felt Dr. Gabe was making a difference by connecting with the students. Mrs. Clay encouraged the Board to use Sparta High School graduates as part of the coaching staff.

Leslie Sauzek asked about the dress code. Cold-shoulder straps are permissible. Mrs. Sauzek felt that some of the things that the teachers wear were inappropriate.

With no other public comment requests, the meeting continued.

Angela Craig moved, Howard Gallois seconded to approve the minutes of the August 10, 2017, regular meeting and the amended minutes of the August 31, 2017, special meeting as presented. Roll call vote. Yeas: Craig, Gallois, Kempfer, Young, Byington and Holliday. Nays: none. Motion carried.

Mr. Kempfer had questions about the checks for Hope School, East Perry Lumber and Mark Twain Hotel. There is one student attending at Hope School. Mr. Stork has saved \$800 by using

East Perry Lumber out of Missouri. Mark Twain Hotel is the hotel that four teachers will be staying at for the Illinois Reading Conference. The two back tires of the Kubota tractor had to be replaced. The cost was \$900. Businesses have been reimbursing the district if they sponsored a banner.

The next regular board meeting will be October 12, 2017, at 7 p.m. at Tilden Fire Department.

Principal Jayson Baker announced that Evansville Attendance Center athletics are doing well. The trash bag fundraiser had a profit of over \$1,000. There will soon be professional development on trauma training for teachers. The school also has new clocks that were purchased by the PTO. The students at Evansville Attendance Center will have band on Tuesdays and Thursdays. The NWEA assessment is almost complete. Officer Jones has also brought the K-9 unit to visit the students.

Mrs. Amy Price reported that Sparta Lincoln School is in the middle of testing. The teachers have been doing the second year of Engage New York Math and English/Language Arts, along with Evalu-wise.

Sparta High School Principal Beckley expects the students to finish testing this week. The homecoming football game will be September 22 with the dance on September 23 in the gymnasium. Teachers Larry Pierson and Kelly Schlueter started a fundraiser for the victims of the hurricane. They shipped 20 ½ pallets.

Mr. Gallois asked about the replacement of the Evansville Attendance Center gymnasium flooring. Dr. Schwemmer has been in contact with other architects. It will be discussed again after she has heard back from them.

Sixth day enrollment was discussed. The district is down two students this year from last year.

Human Service Center provided services for 69 district students last year.

SAT scores were discussed. 46% of the juniors met the benchmark goal in English. In Math, 17% met and 72% did not meet on the SAT. With the Title budget, she will look at math consulting and they will have more support at Sparta High School.

Sparta University had 35 people in attendance. This month the workshop is on NWEA reporting. They will have a graduation ceremony on May 11, 2018.
